Note: Unless the meaning would have been changed, quotations from primary literature have been harmonized silently as regards punctuation, euphonic combination (*saṃdhi*), spelling variations, and transliteration. The titles shown for works of primary literature do not always follow the ones printed in the editions used. The titles for subunits (chapters etc.) of these works are often not found in the works themselves, and have been abstracted from colophons or scholarly conventions. The chapters of the *Pramāṇavārttika* are counted as follows: 1. *svārthānumāna*, 2. *pramāṇasiddhi*, 3. *pratyakṣa*, and 4. *parārthānumāna*.
